Air Industries Group ("Air Industries" or the "Company") is filing this Notification of Late Filing on Form 12 b - 25 with respect to its Quarterly Report on Form 10-Q for the period ended March 31, 2023 (the "Form 10-Q"). The Company today filed its Annual Report on Form 10-K for the year ended December 31, 2022, and has determined that it is unable to file the Form 10-Q within the prescribed time period without unreasonable effort or expense because it requires additional time to complete its financial statement preparation and review process. The Company does not anticipate filing the Form 10Q on or before Monday, May 22, , 2023, the 5 -calendar day extension provided by Rule $12 \mathrm{~b}-25$. The Company plans to file the Form $10-\mathrm{Q}$ as soon as possible and, in all events, within the period required to regain compliance with the timely filing criteria set forth in Section 1007 of the NYSE American Company Guide.

The Company intends to announce preliminary financial results for the quarter ended March 31, 2023, as soon as reasonably practical, in advance of the filing of the Form 10-Q.
